Required Education & Experience

Bachelor’s Degree in Counseling, Business, Personal Finance, Real Estate or related field. Two to four years professional experience in counseling, loan origination, banking or real estate. An equivalent combination of education and experience may be considered. Employee must be familiar with computer skills.

Conditions of Employment:

Background check with state and Federal law enforcement agency required. Selected applicant must submit to a post offer pre-employment substance abuse screening test and receive a negative result for the use of drugs and alcohol as specified in agency policies. General Duties & Responsibilities

 - Conducts group presentations on financial and housing related topics as directed.
