Required Education & Experience:

High School Graduate or General Education Degree (GED) with a Child Development Associate (CDA) Credential or currently enrolled in a CDA program to complete the credential within one year upon date of hire. (Proof of enrollment must be provided).(Proof of enrollment must be provided); AA or BA Degree in Early Childhood Education with 2 to 4 years related experience in an early childhood educational setting. An equivalent combination of education, training and experience may be considered.

Conditions of Employment:
