#### **Required Education/Experience:**

High School Diploma or General Education Degree. One to two years' experience in cleaning and caretaking of buildings.

#### **Conditions of Employment:**

Background check with state and Federal law enforcement agency required. Selected applicant must submit to a preemployment substance abuse screening test and receive a negative result for the use of drugs and alcohol as specified in agency policies. Must submit and receive negative results for random testing of same. Must be able to pass a post offer physical examination.

#### General Duties & Responsibilities:

Maintains Head Start Center building and grounds in a clean and orderly condition in accordance with NC Day Care.

- Keeps Head Start building and grounds in clean and orderly condition as required by NC Day Care Licensing Office and agency policies.
- Regulates heating, lighting, and ventilating system.
- Cleans and disinfects bathrooms to include mirrors, fixtures, metal work, partitions, etc... at least twice daily.
- Sweeps indoors and outdoors daily.
- Strips and re-waxes all uncarpeted areas as needed or directed
- Mops center floors at least three times weekly.
- Replenishes paper and soap dispensers as needed.
- Wipes down walls as needed to remove spills, fingerprints, shoe marks, etc....
- Washes windows as needed.
- Replaces light bulbs.
- Redistributes "poured in place" (sand, etc.) in areas around playground equipment at least twice weekly.

#### Knowledge:

Applicant must be able to:

- Have knowledge of standard methods and practices, tools, and equipment used to clean buildings and furniture.
- Have knowledge of the qualities and uses of various cleaning, sanitizing, stripping and waxing compounds. Applicant must have:
  - Good health as evidenced by an annual physical examination
  - An annual TB test indicating free of TB.
  - Must be at least 21 years of age.
