**Required Education/Experience:**

High School Diploma or GED with 2 years experience driving large transport vehicles; or equivalent combination of education and experience.

**Conditions of Employment:**

Background check with state and Federal law enforcement agency required. Selected applicant must submit to a pre-employment substance abuse screening test and receive a negative result for the use of drugs and alcohol as specified in agency policies. Must submit and receive negative results for random testing of same. Must be able to pass a post offer physical examination.

Action Pathways, Inc. is an "at-will" employer. Either the employee or Action Pathways, Inc. may terminate the employment arrangement at any time, with or without cause.

Must have and maintain a valid NC Commercial Driver's License (CDL) with the School Bus Certification and Passenger & School Bus Endorsement.

**General Duties & Responsibilities:**

Drives bus to safely transport Head Start children over specified routes between homes and centers, according to time schedule and on designated field trips; cleans Head Start center and grounds.

- Drives assigned route, providing safe transportation for all assigned children. Maintains appropriate logs including daily child transportation logs, fuel logs, and mileage logs.
- Ensures emergency information of assigned children is accurate and updated as needed.
- Inspects bus and checks tires, gas, oil, and water before departure. Responsible for maintaining and cleaning assigned bus. Reports maintenance needs of bus.
- Complies with local traffic regulations. Immediately reports delays or accidents.
- Keeps Head Start building and grounds clean and in orderly condition as required by NC Day Care Licensing Office and agency policies.

**Knowledge:**

Applicant must be able to:

- Read and interpret documents such as safety rules, operating and maintenance instructions and procedural manuals. Write reports and maintain records. Perform basic math.
- Have and maintain a good driving record with no moving violations.

Applicant must have:

- CPR & First Aid Certification; Negative TB test. Must be at least 21 years of age.
- CDL with School Bus Certification & Passenger & School Bus Endorsement.
